(House Bill No. 337, 2006 Regular Session) After July 12, 2011, Basic Local Exchange Service - Primary Line rates may increase above the cap, pursuant to the procedures to increase rates for primary, single, voice grade lines in KRS 278.543.

All Basic Local Exchange Services are identified in the following table and within the appropriate sections of the Company's tariffs. The current price and the maximum price for each Basic Local Exchange Service is shown in the pricing subsection(s) of each tariff section that includes Basic Local Exchange Service. All other tariffed retail services including Optional Telephone Features and Packages are classified as Nonbasic Services. Nonbasic service offerings are set by the marketplace.
